Pacific Gas & Electric Company's (PG&E's) **FastTrack Program** offers technology incentives that can cover up to 100% of the purchase and installation costs of ADR equipment.

Program requirements

To participate in ADR FastTrack, you must be an existing PG&E nonresidential customer and one of the following.

- An office (approximately 10,000-105,000 sq. ft.) that uses a maximum of up to 499 kW
- A retail store (approximately 15,000-150,000 sq. ft.) that uses a maximum of up to 499 kW

You must enroll in an eligible PG&E Demand Response (DR) Program and participate in DR events for at least 36 consecutive months.

PG&E is in the process of defaulting select small and medium customers to Peak Day Pricing (PDP) and as a result customers could pay up to 10 times more for electricity during peak day events.

Apply and install ADR equipment that will automatically reduce your electricity usage during peak day events, helping you to save money on your utility bills.

How it works
