## SCE Charge Ready Home Rebate

The **Charge Ready Home Rebate** provides a rebate for upgrading from an existing electrical panel less than 200-amps to a 200-amp electrical panel and installing a 240V circuit within 25 feet of a dedicated off-street parking spot. Upgrading the electrical panel is the first step to safely install an at-home Level 2 electrical vehicle charger and more broadly, it is the first step to whole home electrification. **Charge Ready Home** offers a geographic-based rebate of **\$2,100** for single-family SCE customers residing in a disadvantaged community (DAC) per CalEnviroScreen or an income-qualified rebate of **\$4,200** for income-qualifying SCE customers.
